1. VISIT OF SARKARI CHHATRALAYA WAGODIA, DISTRICT VADODARA

1.1 It was published in the local newspapers about strikes by the Scheduled Tribes girls of the Government Hostel, Waghodia because of sub standard food provided to them by the cateror. Hon'ble Member, Shri Harshadbhai Chunilal Vasava, National Commission for Scheduled Tribes visited the Government Hostel for girls to have spot visit and redressal of the suffering of the Scheduled Tribes girls. It was learnt during the visit that the food provided was not good, nobody like it and have complained to the authorities even then it was not redressed.



Food was effecting the health of the girls so they had a strike. After the sharp action by the girls and news item in news papers local authorities contacted the girls and persuaded them that they will get better food with immediate effect as such agitation was stopped by the girls.



2.1 Hon'ble Member, Shri Harshadbhai Chunilal Vasava, National Commission for Scheduled Tribes had visited the Commissioner of Tribal Affairs office at Birsamunda Bhawan, Gandhinagar for the problem faced by the girls of Waghodia Government girls hostel for the food provided by the caterer agency fixed by the local authority and action initiated by the local authority but since the matter is related to all such Scheduled Tribes Chhatralaya of different institutes a rational measures are necessary to be initiated by the Tribal Affairs Department and Commissioner office so that hygienic food can be available to the students residing in various Chhatralayas. it was discussed that Sakhi Mandal of local women's organisation was given contract for the catering on priority basis but if any of these organisation is not providing hygienic and nutritive food it should be reviewed and some rational measures be initiated by the Commissioner office.
