1. <u>VISIT OF INDIAN OIL CORPORATION LIMITED (IOCL), MARKETING DIVISION VADODARA</u>

1.1 Hon'ble Member, Shri Harshadbhai Chunilal Vasava, National Commission for Scheduled Tribes visited the Indian Oil Corporation Limited (IOCL), Marketing division, Vadodara on 10.05.2018. Hon'ble Member was welcomed by General Manager, Marketing, he delivered welcome speech also.



1.2 The Marketing office staff is of 103 members in which 70 are general and 33 are SC/STs. Power Point Presentation was also made by the Marketing Division. On completion of the presentation, Hon'ble Member has given speech and discussed with the officials about the system of providing petrol pumps, CNG Pumps, LPG Cylinder

agencies and proportion of the STs in the dealership. He also pointed out that in some cases it is found that the agency is in the name of tribal person but actually it is run by some other people and tribal is not getting share in the profit of the business which should be checked by the officials and STs should get the benefit of the business. Constant monitoring is utmost required to safeguard the interest of the STs. STs don't have the marketing skills for which they should be given proper training so that they may survive in the business.



1.3 The suggestion of Hon'ble member was accepted by them and they assured that any discrepancy found will be corrected by the officials, however, they pointed out that the marketing office of Ahmedabad in the main office of Marketing Division in Gujarat and the system of providing agencies, criteria, policy etc. are being observed and carried out by that office. A meeting of Hon'ble Member should be arranged at Ahmedabad Marketing Division. Meeting ended with thanks.

 - Amitkumar Sr.Clerk BRC Division has requested for transfer to Delhi with bottom seniority policy but still not implemented.
 - Manish S.Jadhav SSC electrical lokoshed Baroda transfer request is pendig with CEE, Churchgate, may be expedited
 - D.M. Vasava Asstt.Draftsmen working under Sr.Div. Co-ordination has not been given promotion on one or another reasons though eligible.
 - Jayant Baviskar orders for transfer on request has been issued but not implemented because further order to be issued by Sr.DPO. Vadodara hasnot been issued.
