Shri K C Parmar briefed Hon'ble Member, Shri Harshadbhai Vasava about the function of the Gujarat Land Development Corporation state wide and in the Tribal areas, it was told that Head office situated at Gandhinagar makes plan for all divisions, targets are fixed for each divisions, allocation of funds for each division also fixed by the Head Office. There are sub-divisions working under the divisions who are working for the villages, Assistant Directors are in charge of sub-divisions. Shri Santosh Parulkar is Assistant Director of Kevadiya sub-division having charge of Vyara Sub Division also, Shri Krishnakant Upadhyay is Assistant Director of Sub Division Chhota Udaipur having charge of Anand Sub Division also.

Sub Division wise budget and expenditure details were provided in the compiled book provided by the Division Office, list of the beneficiaries of different villages was also provided under various schemes of Govt.

The details provided in the meeting were very exhaustive. Hon'ble Member Categorically said to all present in the meeting that work carried out in the villages and the beneficiaries will be examined at the time of spot visit of any of the village decided by him and any complaint and discrepancy found will be viewed very seriously and action will be recommended by the NCST against who so ever found guilty in the matter.

As a surprise spot visit Hon'ble Member decided to visit village Vadadali and Fanta of Sankheda talluka of the Vadodara Division of the GLDC, after spot visit Hon'ble Member decided to visit Surat Division of GLDC next day.
