Meeting with tribal representatives and with Collector and other Senior Officers at circuit house Chhota Udaipur

Hon'ble Member held a meeting with tribal representatives on 31.03.2017 at circuit house Chhota Udaipur followed by the meeting with Collector and other Senior Officers and reviewed the development programmes, reservation policy in respect of Scheduled Tribes in the District. The following issues were also discussed in the meeting:

Health:

It was informed that medical facilities were available in the rural as well as in Scheduled Tribes areas. Trained professionals were also available to provide basic medical treatment. It was also observed by the Hon'ble Member that tribals in the District are aware of ayurvedic medicinal plants and with proper training their knowledge can be proved beneficial in medical treatment. Hon'ble Member suggested to start a proper training programme for tribals who have a basic knowledge of ayurvedic medicinal plants and for marketing he also suggested to tie up with the TRIFED.

Irrigation:

It was informed by the senior officers that Water-harvesting structures such as check dams are the starting point for increasing the area under irrigation. With better and more reliable availability of water through check dams, the tribal farmers have the opportunity to make a transition from the cultivation of their traditional low value crops, to high value varieties including vegetables. Agricultural diversification can be facilitated for these farmers by providing them assured access to quality seeds, fertilizers and extension services. But to actually reap the benefits of better land and water productivity, they need to be able to lift the water from the check dams and convey it to their farms. They need assistance for portable diesel pumps and flexible pipes as they are usually too poor to purchase these on their own, and therefore fail to meaningfully benefit from water harvesting initiatives. Hon'ble Member also advised to increase the Kisan Credit Card facility to purchase agricultural equipment's.



Education:

Hon'ble Member advised to take necessary steps to provide better education facilities to the tribal students for their betterment in the society. Hon'ble Member observed that the essence of the town, however, is that it lies in the heart of a tribal area with rich indigenous history and culture. It was informed that every Saturday there is a haat or tribal market. There is one tribal museum also in the Town. Hon'ble Member felt that there is a need to establish a cultural academy in the District to maintain the tribal culture of Gujarat and he also suggested to dub the tribal local songs. Hon'ble Member also advised to monitor the pre metric and post metric scholarships for disbursement on time.

Meeting with tribal representatives and with Collector and other Senior Officers at circuit house dang

Hon'ble Member held a meeting with the Collector, District, Dang. DDO, DSP and other Senior officers of various departments were also present in the meeting. Hon'ble Member received a warm welcome by the Collector and other officers. District Collector and other Senior officers gives a brief overview about the current situation of tribals in the District.



Following are the issues discussed in the meeting:

Education:

Status of Literacy in Dang District

Hon'ble Member noted that in respect of STs, male literacy (82.54%) as well as female literacy (66.50%) was comparable to the overall literacy in respect of male (83.06%) and female (67.38%).

Hon'ble Member felt that there is a need to draw a concrete action plan to improve the level of literacy among STs, particularly among females. Hon'ble Member advised to critically review the adequacy of necessary infrastructure in education sector and tribal areas for further improvements. The educational curriculum should include personality development, communication skill, computer skill and job oriented training programmes.

Water Scarcity Problem in the District:

Hon'ble Member observed that tribals were facing water scarcity problem in the District and patchy rainfall in the last two years has dried up reservoirs and wells in the district leading to an acute water crisis. Hon'ble Member advised to lay down pipelines in the district to ensure tribal people get drinking water, enough for their cattle as well.
