#### Attended Annual Function at Vyara, District Tapi

Hon'ble Member, National Commission for Scheduled Tribes visited at vyara Distsrict Tapi to attend the annual function organized by the Morarji Desai Arts and Science College, Vyara.

Hon'ble Member received a warm welcome by the office bearer organizing committee of the annual function.

While addressing the gathering Hon'ble Member briefed about the functioning of the Commission and stated that National Commission for Scheduled Tribes is a Constitutional body setup under Article 338A of the Constitution of India. Hon'ble Member also make them aware about the functions, duties and power of the Commission. He also

stated that National Commission for Scheduled Tribes is vested with the powers of civil court.

## Meeting with local tribal Community representatives at circuit house District Tapi

Meeting was held with the local tribal community leaders/ representatives at circuit House, Tapi. Following issues related to tribals of the District and the State were raised by the tribal delegates during the meeting.

- 1. Employment opportunities for the tribal groups should be created in the government sector as well as private sector.
- 2. An industrial training institute should be opened in the State to provide skilled training to the tribals in various trades.
- 3. Tribal marketing co-operative society should be formed for marketing of the produces.
- 4. Other communities are grabbing the land belonging to tribals. The State Government should take effective measures to stop land alienation.
- 5. There is a need to verification of caste certificates as a large number of persons belonging to other communities have obtained bogus caste certificates and entered in Government jobs depriving the real and deserving tribals.

## Meeting with Collector, Superintendent of Police, District Tapi

After having a discussion with the tribal representatives at Circuit house, Hon'ble Member held a meeting with Collector and Superintendent of Police, District Vyara.

Hon'ble Member welcomed by the Collector, Superintendent of Police and other senior officials of the District present in the meeting. Hon'ble Member raised all the problems/ issues related to tribals of the State of Gujarat highlighted by the tribal representatives

during the discussion and directed the Director, Tribal Welfare Department to take necessary steps in solving the problems being faced by the tribal community. It was assured that Commission will take up these issues at the appropriate level with the State Government and Govt. of India.

A meeting was held with the Collector and SP, Vadodara at Circuit house on various issues related to the tribal communities in the State. Before the meeting many tribals met with Hon'ble member with their representations and discussed their problems mainly related education, medical facilities, unemployment etc. with Hon'ble Member. Hon'ble Member shared their problems with Collector and SP during the meeting and also advised them to take necessary steps to provide best education and medical facilities to the tribals and also advised them to take further steps for better employment of tribals.
