VISIT OF ONGC GUWAHATI

- 2.1 Hon'ble Member Shri Harshadbhai Chunilal Vasava visited Guwahati on 25.06.2018 where first meeting was with the AISCSTEWA (All India SC ST Employees Welfare Association) of ONGC Nazira & Sivasagar. Association President Shri P. R. Mili welcomed Hon'ble Member along with General Secretary Shri J. C. Hazarika. During the deliberation and delivery of speech they apprised of the facilities extended to the SC/ST and other poor employees of the ONGC. Merit scholarship for the advance courses started Rs. 1000/- for all the wards of SC/ST and other whose annual income is of Rs. 4 Lacs. A written agenda was submitted to Hon'ble Member in which these points were mentioned in the list of pending issues which was given by the Association to the Management, in which installation of Baba Saheb's statue and renovation / repairing of Association's office at Sivasagar Colony was main.
- 2.2 Shir D. R. Pansingh, V.C. of the Association gave welcome speech. Since the body was newly elected Hon'ble Member congratulated the new body and appreciated the work of Association specially of the Chairman Shri Mili who has been elected in the body repeatedly.
- 2.3 In the speech special homage was given to Hon'ble Baba Saheb for providing special provisions in the constitution of India for SC/ST so that they could get the chance to serve nation and the community specially so he was not only Chairman of the Constitution Committee but was God for all the SC, STs of the nation. Since meeting with association was very brain storming and useful. Hon'ble Member ended meeting with thanks.
- 2.4 In the meeting with management ED of Assam Asset Shri S. D. Maske and Shri S. Maralidharan DGM (HR) had welcomed Hon'ble Member. During the discussion of the agenda which was given to the management as their pending issue. The matter related to the installation of statue of Baba Saheb. It was told that it will be completed in 3 months. ED was advised to fast the progress. Point no. 2 was that of the renovation/ repairing of Association's office in that also ED told to complete it during 2018-19. Other issues in the agenda were also discussed in which higher budget for sports because it is golden jubilee year of Association. ED assured that local head for the sports has been instructed to speed up and have total concentration on the issue so that can be materialised up to September 2018. The issue of backlog was discussed and it was told that in December it gets verified and in March it gets certified while in other Govt. Departments matter related to backlog if it is very high of the STs it should be taken up by NCST with the ministry of Tribal Affairs. The issue of training to STs in House and abroad was also in the deliberation in which it was told that

- It was also an issue of Annual Component Plan for ST. it was advised that if sanction is late looking the utilisation of funds of the last year administration should prepare for the utilisation of funds so that question of lapse of the funds may not arise.
- The discussion was very fruitful; Management was very keen for the redressal of the issues raised in the agenda provided by the Association. Meeting ended with thanks.
